

ORDINANCE NO. 2023-11B

AN ORDINANCE OF HANCOCK COUNTY, INDIANA  
APPROPRIATING FUNDS ON HAND TO REDEEM A  
CERTAIN OUTSTANDING BOND ANTICIPATION NOTE OF  
THE HANCOCK COUNTY BUILDING CORPORATION AS  
LESSOR TO HANCOCK COUNTY AS LESSEE

WHEREAS, the County Council of Hancock County, Indiana ("County") has determined to provide funds on hand of the County to redeem certain outstanding Local Income Tax Lease Rental Bond Anticipation Notes, Series 2020 ("Outstanding Note") of the Hancock County Building Corporation ("Corporation"), issued pursuant to a Trust Indenture, dated as of September 1, 2019, as supplemented and amended by a First Supplemental Trust Indenture, dated as of December 1, 2020, between the Corporation and The Huntington National Bank, as Trustee, and originally issued to finance the acquisition, construction and equipping of a county jail;

WHEREAS, the County has determined to provide funds on hand of the County to redeem the Outstanding Note of the Corporation; and

WHEREAS, a notice of a public hearing on the appropriation of funds on hand of the County in an amount not to exceed One Million Two Hundred Ninety-four Thousand Seven Hundred Thirty Dollars (\$1,294,730) to be used for the purpose of redeeming the Outstanding Note was properly published in the *Daily Reporter* and the proof of publication was presented to the County Council and placed in the County's records;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COUNCIL OF HANCOCK COUNTY, INDIANA, THAT:

Section 1. An appropriation in an amount not to exceed One Million Two Hundred Ninety-four Thousand Seven Hundred Thirty Dollars (\$1,294,730) is hereby made to be applied on the costs of redeeming the Outstanding Note on December 15, 2023, and that the funds to meet said appropriation be provided out of funds on hand of the County heretofore authorized; that said appropriation be in addition to all other appropriations provided for in the existing budget and tax levy for the current year.

Section 2. The Auditor is hereby authorized and directed to report and certify the additional appropriation to the Department of Local Government Finance.

Section 3. This ordinance shall be in full force and effect from and after its passage.

Adopted this 13th day of December, 2023, by a vote of 7 ayes and 0 nays.
